## SC to hear Ayodhya case all 5 working days in wk

Departs From  
Thrice-Weekly  
Hearings Norm

New Delhi: Departing for the first time from the tradition of three-day-a-week hearing by constitution benches, the Supreme Court on Thursday decided to hear the appeals in the Ayodhya land dispute on all five working days of the week to provide counsel adequate time to conclude submissions and enable the court to render a judgment.

pised the counsel when it said it would hear the case on all working days of the week. Till now, Constitution benches heard important cases for three days – from Tuesday to Thursday. Mondays and Fri-

days are kept for fresh cases.

The departure from tradition signalled the bench's intent to do justice to the hearing process on the Ayodhya case. The judges decided they should maintain their focus on the case, whose records run into over 20,000 pages.

"Breaking of the bench to allow judges to sit in different combinations on Mondays and Fridays will distract them from the focus required for hearing the Ayodhya case. The judges have to read case documents on record, which is time consuming. Reading around 60-70 petitions listed every Monday and Friday will divert focus as they not only have to read case files but also write verdicts in some of them," an SC source told TOI.

## Steep rise in limits for I-T filing tax appeals

Mumbai: The threshold limits for filing of appeals by the Income tax department with tax tribunals, high courts and the Supreme Court were raised by the Central Board of Direct Taxes on Thursday especially to cut down litigation backlog and usher in a taxpayer-friendly regime.

In a significant upward

revision, the circular said the

I-T department cannot file an

appeal before the Income Tax

Appellate Tribunal unless the "tax effect" is Rs 50 lakh.

It was Rs 20 lakh earlier. The

limits for appeals before HCs

and the SC are now Rs 1 crore

and Rs 2 crore, respectively.
