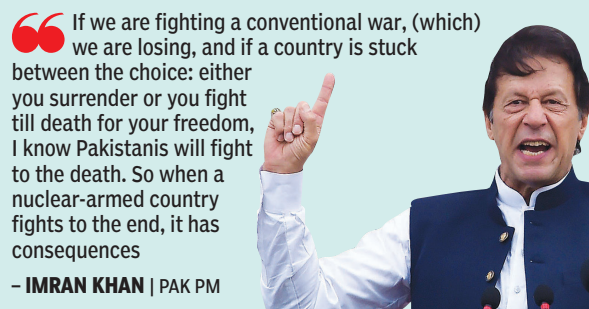
Loss in a conventional war may trigger N-conflict, warns Imran

Islamabad: Pakistan Prime Minister Imran Khan has raised the spectre of a nuclear conflict with India over the Kashmir issue, saying it could be a "consequence" in case of Islamabad losing a conventional war against New Delhi.

In an interview to Al Jazeera that was telecast on Saturday, he reiterated that nuclear war between the two neighbours could be a possibility.

"When two nuclear-armed countries fight, if they fight a conventional war, there is every possibility that it is going to end up into nuclear war. The unthinkable."

While reiterating that Pakistan would never start a war against India, he said: "I am a pacifist, I am anti-war. If say Pakistan, God forbid, we are fighting a conventional

Govt looks to plug GST leaks, boost collections; meet on Fri

New Delhi: Having detected frauds of close to Rs 50,000 crore, the Centre is looking to tighten processes, including those related to claiming input tax credit, and will focus on getting states to okay plans to plug leaks and evasions at this week's GST council meeting.

The government's effort to shore up collections and improve revenues is likely to be a major area of discussion at the GST council. Calls for rate cuts

Bees 'ambush' plane, force 90-min delay

Kolkata: A swarm of bees took an Air India aircraft, with a Bangladesh minister on board, "hostage" at Kolkata airport for more than 90 minutes on Sunday morning before "heavy artillery" — in the form of water cannons — was brought out to clear the cockpit windshield of the buzzing menace.

Flight AI 743 to Agartala was about to enter the runway for take-off at 11.13am when the bees came out of nowhere and ambushed the windshield, blindsiding the captain and the first officer just as they prepared to hit full throttle. The flight finally took off at 12.56pm.
